15/01 Public Questions

PCSO Amy Thompson joined the meeting and introduced herself to the Council. She informed the council of her role and parishes that she covers. - S106 Funding is due to go to the next Finance meeting of the SNC council for approval.
- Clarification was sought as to the SNC Contribution to Superfast Broadband and the following was approved:

It has now been concluded that as it is not possible to fund the Grange Park Parish Council contribution to superfast broadband via the levying of a special expense pursuant to section 35 of the Local Government Finance Act 1992, it will be funded from General Fund balances per the resolution at Council on 17 December 2014. In essence this means that up to £169,000 of the cost will be met by the district council subject to confirmation that the parish council will contribute £20,000 to the scheme.

that the Parish Council would sign the 10 year Control Agreement . Vice-Chairman Cllr S Dawson duly signed.

- 10.3 The Council agreed that Youth Inspired in conjunction with SNC would provide some craft activities for January/February. It was agreed that they would produce the poster and we would advertise on our website.
- 10.4 It was noted that a quote had been received for the boarding/lighting of the roof space within the community centre to comply with Health and Safety legislation for the purpose of fire sensor inspections. The Parish Clerk was aasked to obtain a further two quotes. **Action: Parish Clerk**
- 10.5 The Parish Council considered a request from Regiment Fitness to use the grassed area of the Country Park for the weekly fitness sessions. The Council agreed that they would not be able to use this site during the wet weather months as severe damage is being caused to the current football pitches and outfield. The Parish Clerk was aasked to relay this message and suggest some alternative sites for consideration ie. Wootton Country Park or Grange Valley Greenway.
