15/199 Chairman's Report

199.1 The Chairman made an emotional announcement that one of our Councillors, Stuart Ash had been admitted to hospital over the New Year and diagnosed with terminal cancer. Our thoughts are with his family and partner at this difficult time. Due to this the Council agreed to just deal with any imminent issues and defer everything else to our next meeting in February.

After a brief discussion, it was agreed that the Parish Council has no powers in which to give financial help to individuals but felt that it was a worthy cause and therefore would allow her to use our facilities free of charge to do a table top sale or coffee morning.
- 201.6 The Parish Council considered a grant request from 1st Grange Park Rainbows for the purchase of some craft materials and badges. It was agreed to donate £250 (Local Government Act 1976 Miscellaneous Provisions S19)
