#### Our Wellbeing Service is on the road!

Since the beginning of May our Big Lottery funded Rural Wellbeing Service has been going out to several villages in East Northants. This four year project, covering the county of Northamptonshire, will help tackle issues of social isolation and loneliness in older people by taking our information bus out to villages offering **FREE** advice and support. The service will also aim to set up a



countywide network of volunteer Good Neighbours who will continue the delivery of support to older people in their communities.



If you have been in the vicinity of Collyweston, Warmington, Nassington, Easton on the Hill or Oundle over the last few weeks, you may well have seen our bus (shown here) out and about in the villages. Linda, our fieldworker who is on board the information bus, has been giving advice, resources and support to older

people, carers and others in these villages. Where more specialized support is required, she is able to signpost people to the most appropriate agency to meet their need. We then follow up the referral to the other agency to check the person's needs have been met.

Among a number of referrals, Linda has helped a 96 yr old in an isolated village receive a library at home service, arranged for Care and Repair to put in grab rails and give energy help to a vulnerable lady living alone and provided wet room advice and information to a older couple. She has also started to recruit several potential Good Neighbours.

We are looking to recruit a network of volunteers, Good Neighbours, who can continue the support in the village that has been started by the fieldworker on the information bus. We have more information about Good Neighbours on the following pages.

#### **Bulk Oil Buying Scheme**

As you may be aware, Northamptonshire ACRE runs a Bulk Oil Buying scheme. This is for anyone who uses oil or Liquid Petroleum Gas (LPG) for heating and would like to save money on their heating bills.



Many people in rural areas are without mains gas and are therefore reliant on oil. Most individual orders are small, and are consequently at the mercy of high pricing by the oil companies. Fuel poverty is commonly higher amongst those in rural areas and those reliant on oil.

To help combat this, we launched the **Bulk Oil Buying Scheme** in October 2011, which has so far helped save our members over £60,000 against the average prices quoted since it started.

- Membership to the scheme is £20 a year but we are confident you will save that on your first order.
- Last month the price we obtained on heating oil was **36.94 per litre** against an average of 45.40 ppl. Members who ordered **750 litres** saved £63.45 against the average price.

#### **COMMUNITY FACILITIES UPDATE**

#### **Cotterstock Village Hall refurbishement**

Congratulations to Cotterstock Village Hall Committee who have overseen the refurbishment of their village hall, which was originally the local Church school in 1876. The hall is a meeting place for the active Cotterstock community and over the years, wear and tear has taken its toll.

With the aid of a generous grant from WREN of £60,000 and local funding raising that amounted to another £10,000, Cotterstock has been able to restore and repair the floorboards and roof, install a new plumbing and heating system and insulation. The kitchen, windows and doors have been updated and all this has been done while preserving the historic and



beautiful fabric of the building as can be seen in this photo, where it has been dressed for a recent wedding.

## Should Village Halls be Listed as Assets of Community Value?

The Community Right to Bid gives community groups a chance to save assets which are of importance to their community. This could include the village shop, pub, community centre or recreation ground. This is done by listing them as assets of community value. Some village hall committees have asked whether a village hall should also be listed.

National ACRE's legal adviser believes there is ultimately no need to list a village hall that is already in community ownership, because charity law offers the protection needed. However, there is a valid need to list assets that are of community value but not in local ownership such as church and county/district council property.

Provided the Village Hall Management Committee has a secure interest in its hall (freehold or leasehold) no such listing is needed. But, even if a village hall were to be listed, nothing untoward should result from the listing.

#### Irrecoverable VAT on Village Hall Refurbishment



In June, our sister organisation, the National Village Halls Forum, issued a press release regarding the issue of irrecoverable VAT. This can be a big problem for village halls.

Our Community Facility Advisor is aware of an actual case where VAT had a very real impact on a village hall

that recently undertook a major improvement project. The VAT bill came to an astonishing 14% of the total gross cost of refurbishment. Given a funding shortfall, the village hall committee had no option but to register for VAT. In so doing, the committee could claw back the VAT - a short-term gain but with a long-term price to pay.


VAT registration means a commitment of twenty years of charging VAT on income from a hire of the hall but minimal VAT-able running costs against which to reclaim VAT. Add to that the additional complexity (and legal liability) of keeping accounts caused by VAT registration, it's no wonder village



halls (or parish councils) think twice before undertaking major building and renovation works. And this is against a background of dwindling sources of grant funding.

#### **B-Fast: Bucks First Aid & Safety Training**



#### Parley Pole: All about a village

#### A novel about Parish Councils and everyday life


Fish nibbled at the bloated face.

To whom does the body in the stream belong? Was violence involved? Fear takes hold and a relaxed way of life becomes suspended during a protracted murder investigation...

Like many villages in the county, Milton Malsor is in a vulnerable position regarding the expansion of Northampton and the imposition of the 60,000 houses. The Parish Council has fought off many warehouse developments, resisted a minerals site, forced a proposed secondary school to be built at Grange Park where it is needed, developed a Parish Plan and then a Neighbourhood Plan (with a small housing area having very necessary affordable homes), all to protect the parish from random housing and to keep the village's character and surrounding green fields.

Neil Jagger, a parish councillor in Milton Malsor, decided to put all his knowledge and experience of the difficulties and intrigues that happen in a village into a novel, which has recently been published. The book, 'Parley Pole: All about a village' is set in a fictional rural village (surprisingly similar to Milton Malsor) and sets out the inner workings of the various village institutions over eight seasons.

The embattled parish council is covered as above with its more mundane responsibilities like: the full burial ground, the closing of the post office,



the appalling state of the roads and pavements, rat running and speeding; the run down village hall; the overambitious parochial church council; the understaffed care home. All leavened by a village fun day, a school fete and the effect of a murder and its slow solving on the villagers, two love stories, a wedding, farming, pheasant rearing and the interaction of lots of local characters. So life in a normal, average Northamptonshire village!



The novel helps to explain modern life in a rural village with its good and bad points as well as providing an insight into how the planning system works and what parish councils actually do. #### Parish Special Constables & Speed Watch

Excessive speeding and dangerous driving continue to be familiar concerns to residents of many villages throughout Northamptonshire. Whilst the Community Speed Watch Scheme, up until now has been one way to tackle this within villages and communities, the role of the Parish Special Constable could change the way this scheme currently works leading to more effective and more immediate results.



For those who are not familiar with Speed Watch, it is a locally driven initiative where active members of the community come together, with the support of the Police to monitor vehicle speed and driver behaviour. Whilst this scheme is educational, it is

not enforcement in itself and requires the powers of the police to ensure the necessary penalties are issued.

Community members can now change the way this scheme currently works and ensure these concerns are handled more quickly and effectively by having their very own **Parish Special Constable**.

- Parish Special Constables are an exciting new voluntary opportunity with Northamptonshire Police
- It gives local people the chance to be involved in making a real difference within their community.
- Villagers have said they want a police service that is more local, visible, engaged and preventative. Parish Specials are designed to meet these community needs.
- They are fully warranted officers working with regular police officers, parish/town councils and community groups to help resolve issues important to the local community



- They patrol their area in uniform, speaking to people, providing reassurance and discouraging crime and anti-social behaviour.
- They can choose to work in their own community or in neighbouring ones.
- And they can issue penalties for speeding on the spot!

Essentially Parish Special Constables will become the known 'go to 'point for local community issues, providing a clear link between the communities and the police and work with other partners in the parish.



By having a Parish Special Constable in your village, the role can be integrated with the work of the Speedwatch scheme so that where a driver is found to be speeding above the limit, the Parish Constable can issue a penalty on the spot. It also allows them to instantly update community intelligence on force systems. More importantly though, the scheme will have an individual who is familiar with the community in

which they police and has the powers and links to be able to take action where necessary.

On the subject of rural crime, a new network that has been launched to provide greater recognition and understanding of the problems and impact of crime in rural areas so more can be done to keep people safer. The National Rural Crime Network (NRCN) aims to ensure the voice of the countryside is heard by championinga better understanding of crime in rural areas and showing new, effective ways to help to keep rural communities safer.

NRCN is funded by 28 Police and Crime Commissioners and their member Police Forces (including Northamptonshire's own PCC Adam Simmonds), each contributing an initial sum of £2,000 together with £1,000 sponsorship from the insurer NFU Mutual.

#### Rural Productivity Plan unveiled by Defra



Under the government's first ever Rural Productivity Plan, issued by Defra, rural communities will be allowed to build starter homes for local residents. The 10 point plan sets out measures to boost the rural economy by investing in education and skills, increasing wages, improving infrastructure and connectivity, and simplifying planning laws for rural businesses and communities.

Measures include amending planning rules to allow starter homes to be built on Rural Exception Sites for the first

time, which the government says will allow local areas to allocate more sites for starter homes, specifically for people who already live in the area, or have an existing local family or employment connection.

However since its publication on 20th August, there have been a number of concerns and queries raised including a worry that it might not be focusing on the right issues and may not support all rural communities (see the Rural Services Network article: <a href="http://www.rsnonline.org.uk/analysis/whats-not-in-the-rural-productivity-plan">http://www.rsnonline.org.uk/analysis/whats-not-in-the-rural-productivity-plan</a>) and that the plan lacks ambition on rural broadband.

Regarding broadband, the plan says the government is committed to delivering superfast broadband of at least 24Mbps to 95% of UK households and businesses by 2017 with decisions on further broadband rollout to be taken in the Spending Review in November. The plan says: "By the end of 2015, access to standard broadband will be available to anyone unable to get a service of at least 2Mbps, through the option of satellite broadband."

The Country Land and Business Association policy director, Christopher Price, acknowledged that the plan would help the countryside to thrive – but warned that better broadband was still needed. "The challenge of delivering improved productivity in our rural areas is different to that in our towns and cities. Unfortunately this latest plan still falls short of giving rural communities and businesses the confidence that the universal service they are crying out for will be achieved."

It will be interesting to see how well the plan does deliver what it promises.

#### £8m fund available for rural tourism

A further £8m in funding has been made available by the government for rural tourism businesses. The funding is to help businesses unlock the huge potential for growth in the countryside and will build on the government's first ever Rural Productivity Plan (see above). Grants available under the scheme can help people expand and develop new food processing facilities and individual grants worth upwards of £35,000 depending on the individual project will now be offered in another 11 Local Enterprise Partnership (LEP) areas.



The funding is being made available under the Growth Programme: grants for the rural economy programme, which provides funding to help projects in England that create jobs and help rural economy growth. These grants are funded by the European Agricultural Fund for Rural Development (EAFRD). The Rural Payments Agency (RPA) manages the grants, working with LEPs. #### **Giving and getting website**

We have been approached by an organisation that is offering what we feel is a great idea. The Giving and Getting website is a recently launched **FREE** website <a href="https://www.givingandgetting.net/">https://www.givingandgetting.net/</a> that enables people to give and get support, help and favours from neighbours and friends and across generations.

Most of us have no problem asking friends or neighbours for help occasionally with the little things such as putting our bins out, taking in our parcels, or watering the plants. But it is often harder to ask when the favour is bigger, for example lifts to and from the station or airport, sorting out our computer or taking us to the hospital or clinic. And for many people in villages, this can be even more difficult. Having appropriate and accessible practical support networks in their communities could help improve a more isolated person's quality of life.



Giving and Getting is a website that enables people to develop support networks of friends, neighbours and volunteers who will help each other, while having the potential to link people across ages to support each other.

#### How does the Giving and Getting Website work?


It operates on a simple token based system that automatically moves tokens between members and keeps track of how many you have. On joining each member is given 50 tokens and members spend tokens by getting the help they want and receive tokens by giving help and favours requested.

Each member is able to give and get with other members who are in their inner, middle and outer circles. If you get an offer or request from someone you don't know, you can see how that person links back to you by looking on the 'Your circles' page, which gives peace of mind. Best of all membership is free and there is no charge to use the site!

#### **CornerDrop**

Are you a retailer in rural area who would like to increase your footfall? Looking for new opportunities to increase the services you offer to your customers? Or are you a resident who is fed up of waiting in for that important parcel to be delivered? Or getting yet another letterbox card about your missed delivery? If so CornerDrop might be of interest to you. We were recently sent details of this new business. You may know of a retailer who might be interested.



CornerDrop is an online click and collect service that aims to allow any local retailer or business to become a parcel drop for residents in their area while getting paid for this. It could also help increase footfall to the business. When a resident orders an item online from a retailer, they can specify the location they want their parcel to be delivered to provided it is a member of the CornerDrop scheme. They can then pick up the parcel at a time that is convenient to them.

#### **Rural retailers:**

Any rural retailer, such as a community shop, pub or Post Office can become a CornerDrop location. It is free of charge to join and for every parcel you accept, you are paid £0.50 (+VAT) from CornerDrop. You complete an application form and should be able to take parcel deliveries within a week. You are provided with marketing materials, customer leaflets and point of sale material.

#### How does CornerDrop fund this?

The money to pay for the service to the local retailer comes from transactions between online retailers and/or customers. Online retailers and customers purchase codes directly from <a href="www.cornerdrop.com">www.cornerdrop.com</a> to use on any website, in order to specify where the parcel is delivered. #### Faster broadband connection vouchers for SMEs



Are you a small or medium sized enterprise? Are you fed up of your slow broadband holding back your business? Want to upgrade but the connection costs are putting you off? You may be eligible to apply for a government grant of up to £3000 to install faster and better broadband. The grant, in the form of a connection voucher,

is part of the government's broadband transformation across the country.

To see if you are eligible, go to <a href="https://www.connectionvouchers.co.uk/">https://www.connectionvouchers.co.uk/</a> and enter your postcode. Because this is part of the government's <a href="https://www.connectionvouchers.co.uk/">Superconnected Cities</a> scheme you may find that you come up as being part of Coventry! You will then get two options to apply for a voucher:

- An off the shelf deal designed to make the application simple with no forms
- 2. Specific quotes from a broadband supplier in your area and the completion of an application form for your chosen supplier.

There are two amounts available: up to £400 for businesses who want fast fibre to the cabinet broadband and up to £3000 for those who are looking for fibre to the premises or Ethernet broadband. The vouchers cover the connection charges and the router.

Connection Vouchers will be made available on a first come, first served basis until 31 March 2016, but the money is going fast.

#### vinspired Cashpoint Reopens for Applications

If you know of a young person aged 14-25 who has an idea that will solve a problem in your community, then vlnspired Cashpoint is there to help. They could get up to £500 to turn their idea into reality.



- Project is run by 14-25 year old volunteer in the UK
- It has a clear community benefit
- The main aim of the project is not to fundraise
- The project is either completely new or something done before but can be done differently
- At least two 14-25 year old volunteers help the applicant out
- Project costs £500 or less and vlnspired cashpoint is the only funder

#### **British Gas Energy Efficiency Fund**

This fund has been created by British Gas as part of the settlement of an investigation by Ofgem, concluded in April 2014, into British Gas' breaches of its Standard

Licence Conditions. It is designed to help micro-businesses manage their energy costs in the long-term, by providing free expert advice and energy efficiency measures to small/micro businesses.

If your business is eligible, you will receive a free on-site energy survey, as well as fully-funded installations of energy saving measures **valued up to £6,000 per business**, helping you save money on your energy bill. At the Hunsbury Hill Centre, we have recently most of our loft insulated (with sheeps wool as it is a listed building).



Don't be put off by the references to micro-businesses. We contacted British Gas staff who recommended you ring them to see if they can help and that is exactly what Naseby Village Hall committee did. British Gas confirmed their village hall would qualify. As a result, Naseby Village Hall were successful in obtaining a grant under which they had £5,000 worth of work done on the hall, ranging from new efficient lighting to energy efficient insulation.

The bonus of this fund is that British Gas does all the work, through a company called Sustain. You discuss with Sustain what energy efficiency measures you need then you sit back and let Sustains get on with it. And wait for your bills to go down!

The fund will provide up to approximately £150,000 of funding for feasibility and pre-planning development work to help projects become investment ready. The fund is being delivered on behalf of the government by the Waste and Resources Action Programme (WRAP). • Urban Community Energy Fund (UCEF) is the urban counterpart to the RCEF and was launched on 13 November 2014. UCEF is a £10m fund to kick-start renewable energy generation projects in urban communities across England. Community groups will be able to access grants and loans to support renewable energy developments. Grants of up to £20,000 are available and UCEF will also provide loans of up to £130,000 to develop planning applications and a robust business case.

from Ofgem is a government financial incentive to promote the use of renewable heat. Switching to heating systems that use naturally replenished energy can help the UK reduce its carbon emissions. People who join the scheme and stick to its rules, receive



quarterly payments for seven years for the amount of clean, green renewable heat their system produces. The scheme is open to anyone who can meet the joining requirements. It's for households both off and on the gas grid. The incentive has two schemes - Domestic and Non-Domestic, which have separate tariffs, joining conditions, rules and application processes. #### **Green Deal funding stops**

**Please Note**: as from July 23rd 2015, the government has stopped funding to the Green Deal.

The Green Deal was a Government scheme set up to help homeowners pay for double-glazing, solid wall insulation, boiler upgrades and much more from projected savings on energy bills.

New applications for Green Deal loans are no longer being accepted, (unless your application was received before 3.30pm on 23 July). Existing Green Deal loans are not affected and will continue to be repaid as normal.

#### **Sita Trust**



SITA Trust is an ethical not-for-profit funding organisation that distributes funds contributed by the recycling and resource management company SITA UK, for the improvement of the natural environment and community life. It funds projects in any of 100 funding zones around

qualifying sites owned by SITA UK.

The SITA Trust currently funds two programmes:

<u>The Communities Programme</u>: This programme aims to fund projects that make physical improvements to community leisure facilities and historic buildings / structures in any of 100 funding zones around qualifying sites owned by our donor, SITA UK...

- Primary Fund: grants of up to £50,000 for projects with an overall cost of not more than £250,000. Projects must start within 6 months of funding being awarded.
- Smaller Projects Fund: Grants of up to £20,000 for projects with overall cost of less than £40,000. Projects must start within 3 months of funding being awarded.

The next deadline is 12th October 2015 with the notification date of 19th January 2016 for the Smaller Projects Fund and 19th February for the Primary Fund.

<u>Accessing Nature Programme:</u> This programme provides funding for projects that improve physical access to a natural outdoor space resulting in increased opportunities for people to experience and enjoy wildlife.

- Accessing Nature Fund: Grants of up to £50,000 where the project has an overall cost of no more than £100,000. Projects must start within 6 months and complete within 12 months of funding awarded.
- Core Criteria Fund: the project must be based at a single site located in England and it must create or improve the physical access to a natural outdoor space. The project must result in an increase in the number of people who visit the outdoor space to experience and enjoy wildlife.

The next deadline is 28th September 2015 for both funds with a notification date of 19th February 2016.

One thing to note: Before SITA releases funding to any supported project, you need to get an eligible third party to reimburse 11.5% of the cost of the project through a payment called the Contributing Third Party payment (CTP). This is unique to the Landfill Communities Fund. It is because SITA UK only receives a partial tax credit against the donations they make to the Landfill Communities Fund (LCF). This leaves SITA UK with a deficit that is recovered through the CTP payment, which must originate from a person or organisation that doesn't directly benefit from the project.
