## Parish Council

Grange Park Parish Council meets at the Community Centre, usually on the first Thursday of each month (except for August). Meetings normally start at 7:30pm. Minutes from each of the Parish Council meetings are posted on their website <a href="www.grangeparkpc.org">www.grangeparkpc.org</a>. Please note that in each meeting the minutes from the previous month have to be agreed by council members before they can be published, this can sometimes result in a small delay.

Serving as a councillor on any parish or town council is controlled by the rules and regulations laid out in the Local Government Act 1972 (LGA 1972). Grange Park Parish Council has 12 serving councillors. We are currently at full strength but if anyone has an interest in becoming a future councillor then please contact the Clerk.

#### Qualifying criteria - A candidate must be:

A British subject or a citizen of the a citizen of the Commonwealth or the European Union

At least 18 years of age

A local government elector for the area of the authority, or for during the preceding 12 months, lived in the parish or within 3 miles of the parish, have owned or occupied land in the parish, or worked in the parish

A candidate cannot:

Hold paid office or employment within the council

Be subject to a bankruptcy restriction order or interim order

Have been within the last five years convicted of any offence and sentenced to imprisonment for more than three months

Relevant skills are:

Good listening skills, Good decision-making skills, good local knowledge

#### **Grange Park Community & Sports Association (GPC&SA)**

The above group has been in operation for the last two years. However it was recently decided that the group would look to wind down with responsibilities transferring back to the Parish Council once more.

#### **Foxfield Pavilion**

The facilities at Foxfield include a meeting room, a sizeable education room with up to date audio visual equipment and adjoining kitchen servery; four changing rooms and two official's changing rooms-all with shower facilities; an office and a small kitchen for the use of light refreshments. There are also some football pitches and a cricket table which includes an artificial wicket. The sporting facilities have been greatly used this year. A few teething problems have occurred with parking and litter which GPC&SA are looking into resolving. Following a twelve month trial period under a temporary adjustment, the Council have recently applied for a variation to the planning consent, to extend the operating hours until midnight.



## **Foxfield Paths & Bridleway**

The paths at Foxfield are kept under constant review. The Parish Council has agreed with the Rights Of Way Officer, NCC to erect bridleway signs around the perimeter of Foxfield Country Park. Northampton County Council has agreed to install a slow down sign at the main entrance to Foxfield Pavilion.

### **Community Activities**

The Parish Council started the year by organising the Jubilee celebrations in conjunction with ASDA as main sponsor. There were various children's activities throughout the day including climbing wall, BMX bikes and many others.



During the school holidays the Parish Council arranged with South Northamptonshire District Council the use of a skateboard ramp and climbing wall every Wednesday evening from 4.30 – 6.30pm.

On November 5<sup>th</sup>, we organised our Annual Firework Display which was well attended and greatly appreciated by the majority of residents within the Community (estimated attendance 2000). We employed the services of the same company as in the previous year. Parish Councillors and staff helped all day setting up. Lots of photographs were taken at this event and included in our Parish Newsletter.





For the first time since formation, we held a family Christmas event with a visit from Santa and performance by a professional illusionist. Again the feedback was positive and it was great to provide an opportunity for families to get together in the festive period.

## **Youth Club**

Grange Park Parish Council have engaged the services of Jenny Evans, Youth Project Leader and her staff who run the youth club at the Community Centre on a Thursday evening and also detached workers connect with the youth on a Friday night within the community. They have arranged many activities within the year which include a trip to the Fire Station at Mereway, Alton Towers, healthy eating and self-esteem workshops and for regular attendees to the Youth Club a Christmas night out ten pin bowling.

#### **Environment**

As reported in last year's report, we took the decision to employ new grounds maintenance contractors. The council are very pleased with the impact R&G Grounds Maintenance have had on Grange Park. Ken and his team have done an excellent job improving the appearance of grass and planted areas. Ken has adopted the role of Contract Manager and willingly engaged with residents to resolve many of the issues raised. We feel the overall appearance has been enhanced with a larger area falling into the contract with costs remaining flat.



The areas which are yet to be included in the contract are Grange Valley Greenway (area at the back of Woodland View Primary School), Barratt's development and the District Centre. If you have any suggestions or feedback regarding any areas of open space, please do not hesitate to contact the Parish Office who will forward your concerns to the contractor and hopefully a solution can be found.

### **Vandalism**

In 2012/13 we have on-going vandalism. The safety of children is being put at risk with items of play equipment being tampered with. If you see or suspect any damage is being caused please report it to the Parish Council Office or phone the Police on the non-emergency number of 101.

#### Communication

The Parish Council are always looking at new ways to improve their communication. At present we have a newsletter, website, notice boards and do leaflet drops to all residents when public consultation comments are required. #### Community Centre/Foxfields/Multi-Use Games Area



The Community Centre/Pavilion and the Multi-Use Games Area (MUGA) is now managed by Grange Park Sports & Community Association. The Community Centre is very busy and hiring slots have been allocated to Community Groups like Brownies, Kumon, Youth Club, etc. The Pavilion is also proving to be very popular with groups including Ozmotion, Zumba Musical Minis, Beavers, Cubs, Scouts, Dance Fusion and Explorers. At weekends and mid-week Grange Park

Cricket Club are using the cricket table and Grange Park Rangers and Wooldale Football Clubs are using the Football pitches for training sessions and matches. A timetable of activities is advertised within the community centre, on the GPC&SA website on <a href="https://www.grangparkcsa.org">www.grangparkcsa.org</a> and quarterly in Grange Park Newsletter.

The MUGA is located adjacent to Woodland View Primary School. It is an astro-based surface and the size of two 5 a side football pitches with flood lights and secured fencing. It can be hired out from 1800hrs onwards all week and all day at the weekends.

#### **Allotments**

The Parish Council have submitted two further applications for the Lark Lane allotment site; one for vehicle access and the other a retrospective application for the change of use from Public Open Space to Allotments. We await news from SNC for a date when the applications will be heard by Planning Committee. SNC are in on-going discussions with the HSE and National Grid regarding the high pressure gas pipeline which runs underneath the allotment site.

Every year we award financial grants to a range of local amenity groups, the 2012/13 financial year was no exception and in fact we awarded grants to the Brownies, cycling club and Grange Park WI.

Our annual accounts comply with the statutory requirement of Local Councils Governance and Accountability Legislation in regard to audit. We undergo an internal audit and our financial activities and governance is assessed by an external auditor appointed by the Audit Commission.

We entered 2013/14 in a strong position to undertake new projects as opportunities arise and we continue to source external funding whenever possible.

It is always good to hear comments, whether positive or negative, about the work we undertake in the village. We cannot be everywhere and rely on residents informing us of things that require attention and even making suggestions for improvements. We cannot operate without this feedback and are extremely grateful to those residents who take the time to assist us in our work.
